### MESSAGE FROM OUR CHIEF EXECUTIVE

As the world moved on from the pandemic during this financial year, Chain of Hope was able to return to full activities. This included the mobilisation of our specialist volunteer medical teams who travelled internationally to treat children, as well as mentor and train local healthcare professionals. We were once again able to hold live fundraising events, enabling us to connect in person with our volunteers, supporters and beneficiaries.

Our specialist medical teams were able to conduct an incredible 19 missions, performing 253 procedures. Our sustainability efforts to supply vital medical supplies reached a further 161 patients.

Our International Child Referral Programme transferred 20 children for complex, emergency treatment. Many of these patients had only days or weeks to survive. We are most grateful to our incredible medical retrieval team who assisted our logistics team with complex transfer arrangements. Many personally provided the medical

care to our little patients to ensure they reached their destination safely.

Overall the charity enabled 438 complex procedures, owed largely to our amazing volunteer medics, nurses technicians but also to our incredible fundraising committees.








We had an incredible year in fundraising by being able to hold live events but also through our individual major donor and Trusts and Foundation fundraising.

Over the last financial year, our team successfully transferred 20 children from Uganda, Rwanda, The Gambia, Kenya, Ethiopia, Yemen, Jamaica and Zambia for urgent heart surgery.

These children were treated at the Aswan Heart Centre, Sant Joan de Déu Barcelona Hospital, and Royal Brompton Hospital, London.

**BECCA** FROM RWANDA

Three-year old Becca was born with Tetralogy of Fallot and needed urgent heart surgery to survive.

In January, Chain of Hope arranged for Becca to fly from her home in Rwanda to the Sant Joan de Déu Barcelona Hospital to have corrective heart surgery.

Becca was accompanied by one of our very dedicated medical escorts Dr Uche Anene-Nzelu, as she required oxygen in the air.

Becca had a successful surgery, recovered very well and flew back home with her dad.

Since returning to Rwanda, Becca became a big sister and is actively helping her parents care for her little brother.

# **FIRST CHAIN OF HOPE** PATIENT TREATED IN THE UK SINCE THE PANDEMIC

Mariam is 13 years old from Mombasa in Kenya and had open-heart surgery at the Royal Brompton Hospital in London with Consultant Paediatric Cardiac Surgeon, Mr Andreas Hoschtitzky.

Mariam was born with a condition called Tricuspid Atresia and she had her first surgery in 2010 at the Royal Brompton Hospital when she was nine months old.

In 2022, Mariam became more cyanosed. Due to her heart condition, she was getting very tired and appeared quite blue due to her low oxygen saturations. Chain of Hope arranged for volunteer medical escort, Dr Edgar Brincat, to fly out to Nairobi to collect Mariam and bring her safely to the UK as she needed oxygen on board the plane.

> Since her surgery, Mariam has made an incredible recovery and continues getting stronger every day. Soon after she was discharged from hospital, she started to walk further and climb stairs. This would have been impossible for Mariam before her surgery as she would easily become breathless and tired.

# SUPPORTING THE LIFE-SAVING WORK AT THE **ASWAN HEART CENTRE**

During the financial year, Chain of Hope continued to support the Aswan Heart Centre with vital cardiac medical supplies to the value of £230,000.

These supplies were used by the local team at the Aswan Heart Centre to operate on children and young adults.

Included in these shipments were heart valves, balloons and oxygenators. Many of these supplies are extremely difficult to obtain in Egypt and are essential for major corrective heart procedures performed at the Aswan Heart Centre.

# SAVING THE LIVES OF CHILDREN IN THE MIDDLE-EAST

Chain of Hope continued our humanitarian missions to treat children from Syria, Iraq, Yemen and the Palestinian Territories.

During the year, the charity carried out four missions to the region treating 55 children.

Three of these missions were in partnership with Gift of Life Amman and led by our volunteer cardiac surgeon, Dr Mark Turrentine from The Riley Hospital for Children in Indianapolis. Dr Turrentine has conducted a total of 35 medical missions to the region to help these children.



In August 2022, Dr Turrentine was joined by Chain of Hope's volunteer cardiologist, Professor Sir Shakeel Qureshi from the Evelina London Children's Hospital, who worked to treat seven children in the catheter laboratory.

The fourth mission in this project was conducted in partnership with Gift of Life International at the Abdali Hospital in Jordan.

Cardiac Surgeon, Dr Vaughn Starnes led a surgical team from the Children's Hospital Los Angeles treating 10 children.

# RAWIA FROM SYRIA

### One year-old Rawia is one of the children treated during our humanitarian missions.

Rawia is from a small island off the coast of Syria called Arwad. She was born with a life-threatening heart defect known as pulmonary atresia with ventricular septal defect.

This meant her heart and lungs were not fully developed and Rawia was not getting enough oxygen in her body. She needed urgent surgery to survive.

Chain of Hope arranged for her to travel to Jordan to have her life-saving surgery with our volunteer medical mission team. Her parents drove over six hours from their home in Arwad, Syria to Amman, Jordan.

Dr Mark Turrentine performed open-heart surgery on Rawia and within four hours, her oxygen levels went from 60% to 100%.

# SUPPORTING THE DEVELOPMENT OF A SUSTAINABLE CARDIAC SERVICE IN JAMAICA

During the year, Chain of Hope supported the local team in Jamaica by sending eight visiting cardiac teams to the Jamaica Children's Heart Centre in Kingston.

All these trips were funded in partnership with Rotary and Gift of Life International.

During this period, 62 complex cardiac procedures were completed.






Five of these were ICU surgical mentoring missions with visiting supplemental ICU nurses, intensivists and perfusionists. These were instrumental in supporting local cardiac surgeon, Dr Sherard Little to perform open-heart surgeries on Jamaican Children. In addition, we conduced three catheter missions to treat children in the bi-plane catheter laboratory that was originally funded by Chain of Hope, Gift of Life, Rotary International and The Shaggy and Friends Foundation.



These catheter mission teams were led by Dr John Thomson from the Johns Hopkins Children's Center and Dr Robert Yates from the Great Ormond Street Hospital for Children.



Chain of Hope has been conducting medical missions to Jamaica since 1996 and successfully partnered to open the first dedicated paediatric cardiac facility for the English-speaking Caribbean in 2017.

# **PARTNERING TO SAVE LIVES** OF MORE CHILDREN WITH HEART DISEASE

### Kosovo

Due to the devastation of war, affordable health services for serious diseases like congenital heart disease are nearly impossible in Kosovo.

Chain of Hope partnered with Gift of Life International and conducted two specialised medical missions to Kosovo to provide complex cardiac care to 38 children with life-threatening heart conditions.



These missions were led by a team from The Albany Medical Centre in New York City with Cardiac Surgeons Dr. Neil Devejian and Dr. Kellianne Kleeman.

### **The Dominican Republic**

Gift of Life International Cardiac Surgeon Dr Rodrigo Soto and Cardiologist Dr Lee Benson from Sick Kids Toronto, led two missions to the Cedimat Hospital in Santo Domingo carrying out 47 procedures on children suffering from heart disease.

### Ramallah

Chain of Hope worked in partnership with the Palestine Children's Relief Fund (PCRF) and the Aswan Heart Centre to sponsor a training placement for three cardiac nurses from Ramallah.

Mahmoud Maale began training in Cardiac Cath labs at the Aswan Heart Centre alongside Jehad Dahdoul and Mostafa Jamal, both training in paediatric intensive care.

These training programmes were part of a knowledge-exchange programme in cardiac nursing for the further development of nursing skills at the PCRF Paediatric Intensive Care Unit at the Palestine Medical Complex in Ramallah.

### **Ethiopia**

As we continue to support the paediatric cardiac programme at the Cardiac Centre Ethiopia, 19 children suffering from heart disease were treated through the support provided by Chain of Hope during the financial year.

This year's Chain of Hope Gala Ball was a highly anticipated event, marking the charity's first Gala in three years due to the COVID-19 pandemic.



The evening was a postponed celebration of the charity's 25th anniversary and was a long-awaited opportunity for supporters to come together and commemorate the work that Chain of Hope has done for children with heart disease over the last 25 years.

The Gala Ball took place on 11 November 2022 at the Natural History Museum in London, with almost 400 guests in attendance. It was an opportunity for the guests to show their support for the charity's life-saving work, and they did so in style, raising over £1.8 million. The evening's host, Jonathan Samuels, kept the crowd entertained and engaged while master auctioneer Lord Archer sold some amazing money-can't-buy prizes. Guests were also treated to live performances by Paloma Faith and Beverley Knight.

### H.R. OWEN Charity event

In October 2022, luxury car retailer H.R. Owen Group, hosted their inaugural charity shoot in aid of Chain of Hope, successfully raising over £55,000 for children with heart disease. ### DCD Awards 2022

Chain of Hope was honoured to have been selected as Charity of the Year for the fifth year at the Datacentre Dynamics (DCD) Global Awards. Thanks to the generous support of the 800 attendees, an incredible £30,150 was raised for children with heart disease. During the ceremony, actor and Chain of Hope ambassador, Colin Salmon, took to the stage to deliver a heartfelt speech about the work of the charity and thanked the guests and the organisation for their support over the last five years.

### **Challenge Events**

### We were pleased to have 15 incredible runners taking part in two challenge events within the year raising over £32,000 for children with heart disease.

The Royal Parks Half Marathon and the London Marathon had a team of runners including two staff members and two of our medical volunteers.

Thanks to the Urban Fox Orchestra Steelband, headed by long-time supporters of the charity, Colin Salmon and Fiona Hawthorne who helped created a cheerful atmosphere for our runners as they passed the Chain of Hope stand in Hyde Park.



#### Mr Tom Narducci

In May 2022 the charity lost our long serving Child Protection advisor. Mr Tom Narducci. Since 1998 Tom has worked with Chain of Hope as our Child Protection advisor and Host Family Panel assessment member.

Tom's long career with the NSPCC as a Senior Child Protection Consultant made him an excellent advisor to Chain of Hope and a trainer of our staff and volunteers. He helped to ensure the safety of our patients is always at the forefront of the charity's operations.

#### Professor Marc de Leval

Professor de Leval was Vice-President and a Trustee. He sadly passed away in summer 2022 after a long illness. Professor de Leval was legendary within the cardiothoracic world for his pioneering work in paediatric and neonatal cardiac surgery.

In 2020 Professor de Leval released his autobiography titled, 'Humanity and Humility; 40 years in Children's Heart Surgery' with all proceeds going to Chain of Hope's work, helping to provide care for patients with heart disease as they go on to adolescence and adulthood.

#### Maura has been a volunteer with Chain of Hope for 18 years and has recently taken on the role of 'Safeguarding Trustee.'

Maura also sits on the Chain of Hope Nursing Board and the Risk Committee. She directs nursing training programmes in Ethiopia, Jamaica and Uganda. Her extensive knowledge in patient care and safeguarding brings an invaluable skill set to the Chain of Hope Board.

#### Jason is a qualified solicitor in the UK with 18 years of professional experience and acts as the EMEA General Counsel for a large banking group in the asset management sector.

Jason's involvement with Chain of Hope was borne out of his wish to deploy his legal skills in the charity sector for the benefit of others, something he wished to do for many years and which would complement his professional commitments.



# FINANCE REPORT

In the 12 months to 31 March 2023, the charity's income was over £5m with a total expenditure of £3.9m. For every £1 raised, 78p was spent on charitable activities, 17p on raising more funds and 5p on essential support for the charitable activities.

Fundraising was highly successful during the financial year with major donor fundraising and the return of the annual Gala Ball in November 2022 surpassing expectations by raising over £1.8 million. These donated funds will enable the charity to continue its vision of providing access to cardiac care to children around the world. The charity continues to ensure that costs are carefully monitored as operational and fundraising activities return to normal levels post-pandemic.



### Dariel Housego, Finance manager


